Re: Lawyer Saw Kyaw Kyaw Min

In October 28, 2008, lawyer Saw Kyaw Kyaw Min was accused of engaging in an offence described as contempt of court / disrupting judicial servants while defending clients in a criminal proceeding. The alleged criminal act involved Saw Kyaw Kyaw Min's refusal to make his clients face the court after his clients had turned their backs in protest against the proceedings against them. Radio Free Asia and others reported that Saw Kyaw Kyaw Min was sentenced to 6 months imprisonment for this act. Fearing arrest, Saw Kyaw Kyaw Min fled to Thailand.

In May, 2012, Saw Kyaw Kyaw Min reportedly returned to Burma. It has been reported that he was arrested and imprisoned in late August in relation to the 2008 contempt conviction, and that he was arrested on the same day that his name was removed from the country's blacklist.

It is reported he is now serving a six month sentence.

In the last several months at least 11 lawyers in Burma have been re-admitted to the Bar. Those lawyers had been disbarred for what we regard as proper and appropriate activities in their role as lawyers. We were very pleased to see that they were allowed to return to the legal profession. We regard their re-admission as a sign of the continuing progress on the road to democracy for your country and we congratulate you on the changes that have come about since you were chosen as President of Myanmar.

In our view Saw Kyaw Kyaw Min's actions in court, the actions that led to the contempt finding, were the proper actions of a lawyer in representing his client(s).

Re: Lawyer Saw Kyaw Kyaw Min

We urge you to immediately commute the six month sentence that Saw Kyaw Kyaw Min is serving. Such an action by you will re-enforce the view that things are changing for the better in Myanmar. And will re-enforce the perception that lawyers in Burma will be free to carry on their activities as lawyers, without the fear of disbarment and imprisonment.
