Oral Statement to the 51st Session of the UN Human Rights Council from Lawyers' Rights Watch Canada (LRWC), NGO in special consultative status

Myanmar: Military abuse of laws and courts to commit atrocity crimes

Mr. President,

Lawyers' Rights Watch Canada and the International Bar Association Human Rights Institute thank the Mechanism for its ongoing work in the face of limited resources, lack of access to Myanmar, and intensifying conflict.¹ We draw the Council's attention to parts of the Mechanism's report that focus on the Myanmar military junta's systematic abuse of laws and legal institutions to commit atrocity crimes.

We condemn the recent executions of pro-democracy human rights defenders after secret, in absentia, and unfair trials by military tribunals.² These executions along with widespread and systematic arbitrary detention, extrajudicial killings, enforced disappearances, and torture and ill-treatment including sexual violence, may amount to international crimes.³

We call on this Council to ensure the provision of adequate resources to the Mechanism to ensure accountability of perpetrators. We call on all States, including countries in the region, to ensure their cooperation with the Mechanism, and to urge the Security Council to refer the situation to the International Criminal Court.
