Oral Statement to the 51st Session of the UN Human Rights Council from Lawyers' Rights Watch Canada (LRWC), and the International Bar Association's Human Rights Institute, NGOs in special consultative status

Israel: Remedy violations of international human rights law and ensure full respect for rights of lawyers and human rights defenders

Mr. President,

Lawyers' Rights Watch Canada and the International Bar Association's Human Rights Institute are dismayed by the judicial and administrative harassment of Palestinian lawyers and human rights defenders, in an apparent effort to curtail their legitimate advocacy.¹

Israel has misused its vague and overbroad Counter-Terrorism Law in the recent forcible closures² of seven Palestinian civil society organizations (CSOs),³ including legal aid organizations.⁴

Human rights lawyer, Salah Hammouri,⁵ who works with one of the banned CSOs,⁶ has since March 7th 2022 been unlawfully held in administrative detention by a military court without charge or information about the accusations or evidence against him.⁷

Gaza humanitarian worker Mohammad El Halabi received a 12-year prison sentence on August 30th after six years of pre-trial detention and an unduly prolonged, unfair trial based on manifestly false charges⁸ of diverting aid to Hamas. After his 2016 arrest, he was held incommunicado, denied legal representation for 50 days, and reportedly tortured. His lawyer faced unprecedented obstruction of the performance of his professional duties while representing him.⁹

We ask the Council to urge Israel to comply with international law and standards, including the UN Basic Principles on the Role of Lawyers and the UN Declaration on Human Rights Defenders.
